## MINUTES OF THE REGULAR MEETING OF COMMISSIONERS OF THE KANKAKEE VALLEY AIRPORT AUTHORITY

November 13, 2017

Call to Order: The regular meeting for the month of November of the Board of Commissioners of the Kankakee Valley Airport Authority was called to order at 5:00 p.m. on Monday November 13, 2017 in the Board Room of the Robert B. Glade Terminal Building at the Greater Kankakee Airport, Kankakee, Illinois. Present: Commissioners Wilder, McAfee, Glade, Kraetzer, Jacobi, and Kuntz. Also, present: Jeff Benoit, Airport Manager, Pamela A. Rose, Airport Office Assistant, Alex Ault, Airport Operation Leader, and Gary Ratcliff, Airport Operations, Visitors: Mr. Dale Werner, Mr. Steve Tholen from Tholen's Landscape and Garden Center, Inc. A quorum was present.

Approval of Minutes: The minutes from the regular monthly meeting on Monday October 9, 2017 were reviewed. A motion was made by Commissioner Jacobi and seconded by Commissioner Kuntz to accept the minutes as presented. On roll call the following voted aye: Commissioners Wilder, McAfee, Glade, Kraetzer, Jacobi, and Kuntz. Nays: none. Motion carried.

Public Comment: Mr. Dale Werner inquiring about the land acquisition purchase. Mr. Steve Tholen from Tholen's Landscape and Garden Center, Inc. presented information and quote to replace drainage tile that is causing flooding on the property he leases from KVAA.

- Tax Levying Ordinance 17-2: After a brief discussion a motion was moved by Commissioner Jacobi and seconded by Commissioner Kuntz to Ordinance 17-2, Ordinance of The Kankakee Valley Airport Authority Levying Taxes for the Fiscal Year Ending April 30, 2018. On roll call the following voted aye:

- Bank Signature Resolution: After a brief discussion a motion was made by Commissioner McAfee and seconded by Commissioner Kraetzer to update the authorized signatures for the Kankakee Valley Airport Authority for all financial transactions. On roll call the following voted aye: Commissioners Wilder, McAfee, Glade, Kraetzer, Jacobi, and Kuntz. Nays: none. Motion carried.
- Trailer Purchase: Jeff Benoit presented two (2) quotes for a flatbed trailer to move equipment around the airport. After a brief discussion, a motion was made by Commissioner Glade and seconded by Commissioner Kuntz to accept the proposal from Kankakee Truck Equipment, Inc. in the amount of \$ 6,657.00. On roll call the following voted aye: Commissioners Wilder, McAfee, Glade, Kraetzer, Jacobi, and Kuntz. Nays: none. Motion carried

## Manager's Report:

• Hangar/Facility Fee Report: Jeff Benoit discussed the available hangars, facility fees to date, and fuel sold for the month of October. A request was made to get an updated drawing of improvements from Superior Air Ambulance for our files.

Bills Presented: Jeff Benoit presented the bills. Following a brief discussion, a motion was made by Commissioner Kuntz and seconded by Commissioner Jacobi to approve the bills as presented in the amount of \$240,170.41.
